**Know all Men by these Presents, That I, Susannah Kale**

 Four hundred & Thirty five <sup>100</sup> Dollars, in hand paid, by  
 Hogan Queen of Madison County, and State of  
 Iowa do hereby **Sell and Convey**, unto the said Hogan Queen, my  
 by Quit claim all of right and interest in and to  
 the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

The NE  $\frac{1}{4}$  Quarter of the South West  $\frac{1}{4}$  Quarter of Section  
 No (20) excepting 5 acres out of the North East corner, Township
