**Know all Men by these Presents, That We, Mr. Boone and R. A. Wayne and Mary A. Wayne wife of the said R. A. Wayne of ~~Dallas~~ County and State of Iowa in consideration of the sum of Five thousand two hundred and fifty Dollars, in hand paid, by E. Hayes ~~of Madison~~ County, and State of Iowa do hereby Sell and Convey, unto the said E. Hayes**

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

The North East quarter ( $\frac{1}{4}$ ), and the North half ( $\frac{1}{2}$ ) of the South East quarter ( $\frac{1}{4}$ ) of Section Number five (5), and the North West quarter ( $\frac{1}{4}$ ) of the North West quarter ( $\frac{1}{4}$ ) of Section Number Nine (9) in Township number Seventy six (76) North; of Range number Twenty eight (28) West of 5<sup>th</sup> P.M. and the South East quarter ( $\frac{1}{4}$ ) of the North East quarter ( $\frac{1}{4}$ ) of Section number Twenty two (22) in Township number Seventy seven (77) North; of Range number Twenty seven (27) West of 5<sup>th</sup> P.M., and three and three fourths ( $3\frac{3}{4}$ ) acres in the South East quarter ( $\frac{1}{4}$ ) of the North West quarter ( $\frac{1}{4}$ ) of Section number Twenty (20) in Township number Seventy seven (77) North; of Range number Twenty eight (28) West of 5<sup>th</sup> P.M., beginning thirty (30) rods from the North West corner thence East to a stake, thence sixty (60) rods South to a stake, thence ten (10) rods East to a stake, thence sixty (60) rods North to a stake, thence ten (10) rods West to the place of beginning in all three and three fourths ( $3\frac{3}{4}$ ) acres, together with all and singular the improvements privileges and appurtenances therunto belonging or in any wise appertaining.

And We hereby covenant with the said E. Hayes

that We hold said premises by good and perfect title, that We have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever. And We covenant to warrant and defend the said premises against the lawful claims of all persons whomsoever; and the said

Mary A. Wayne hereby relinquishes her right of dower in and to the above described premises. The foregoing warranty of title is intended to cover and does cover every thing and every claim against said premises, except a mortgage executed to one Elizabeth Hughes on the 3<sup>rd</sup> day of May A.D. 1864, by the said M. Boone and R. A. Hayes on said premises the day of payment and satisfaction of which is in consideration of this conveyance assumed by the said E. Hayes the grantee herein.
