to-wit; The South half of the following described Real Estate, being a part
of the West half of the South East quarter of Section Thirty six, in Township
Seventy six, Range Twenty eight, and more particularly described as follows;
Commencing thirty seven and thirty five hundredths Rods west of the South
East corner of the above described tract of land running thence North twenty
five and twenty nine hundredths Rods, thence West Six and thirty two
hundredths Rods, thence South twenty five and twenty nine one hundredths
rods to said South line, thence East along said South line to place of
beginning; containing one half Acre, - And we hereby covenant with
