Davis of the second part, Witnesseth, That the said party of the first part, for and in consideration of the sum of One thousand dollars to him paid by the said party of the second part, the receipt of which is hereby acknowledged, has granted and sold, and by these presents, do grant, bargain, sell, convey and confirm unto the said party of the second part, his heirs and assigns, forever, the certain tract or parcel of Real Estate in the County of Madison State of Iowa, to-wit; The North West quarter of the North West quarter of Section Twenty five (25) and the South West quarter of the North West quarter of the aforesaid Section Twenty five (25) Also Twelve (12) Acres off of the South West corner of the East half of the South West quarter of same Section, - And also Ten (10) Acres Commencing at the North West corner of the South West quarter of the North West quarter of Section number Thirty five (35) commencing at the letter (K) (Surveyors Record) thence East Eighty (80) Rods to the centre of Middle River — Beginning again at the aforesaid corner marked (K) running thence South Ten (10) Chains and Sixty five (65) links, thence East Fifteen (15) Chains to the Center of Middle River thence down the center of said River to the corner marked "9" — And also the East half of the South West quarter of Section Twenty three (23) all in Township (76) Seventy six North of Range Twenty seven (27) West of the 5th P.M. To have and to hold the premises above described, with all the appurtenances thereto belonging, unto him the said second party, and to his heirs and assigns forever. The said William Davis hereby covenanting for his heirs executors and administrators that the above described premises are free from any incumbrance, that he has full right, power and authority to sell the same, and he will warrant and defend the title unto the said party of the second part his heirs and assigns, against the claims of all persons whomsoever, lawfully claiming the same.
