Know all Men by these presents,
that William T. Shelburn and Sarah A.
Shelburn his wife of Clark County Iowa,
in consideration of the sum of Sixteen hundred dollars in hand
paid by Benjamin Simpson do hereby sell and convey unto the
said Benjamin Simpson the following described premises situated
in the County of Madison and State of Iowa, to wit; Fifteen Acres
it being a part of the North West quarter of the South East quarter of
Section No Twenty One (21) Township No Seventy four (74) North of
Range Twenty seven (27) West. Bounded as follows, to wit; Beginning
at the center of said No (21) thence East Thirty Rods, thence South
Eighty (80) Rods, ^{thence West (30) rods, thence North (80) rods.} to the place of beginning, also the West half of the
South East fourth ($\frac{1}{4}$) of the North West fourth ($\frac{1}{4}$) of Section Thirty six (36)
Township Seventy four (74) Range Twenty Eight (28) containing Twenty
Acres more or less, and the ^{South East $\frac{1}{4}$ of the North East $\frac{1}{4}$, and the North East $\frac{1}{4}$ of the South East $\frac{1}{4}$} East half of the North East quarter of
Section Thirty (30), Range Twenty seven (27) West containing Eighty (80) Acres
more or less, and they hereby covenant with the said Benjamin
Simpson that they hold said premises by good and perfect title, that
they have good right and lawful authority to sell and convey the same,
