This Indenture made the Fourteenth  
day of December one thousand eight  
hundred and sixty five between Samuel

Carter and Monica Ann Carter his wife of Siskiyou County  
State of California party of the first part and L C Coltral of  
Madison County State of Iowa of the second part witnesseth  
that the said party of the first part for and in consider-  
ation of the sum of Eight Hundred (\$800.) Dollars lawful  
money of the United States of America to them in hand paid  
by the said party of the second part at or before the en-  
suing and delivery of these presents the receipt whereof is  
hereby acknowledged have granted bargained sold aliened  
remised released conveyed and confirmed by these presents  
do grant bargain sell alien remise release convey and confirm  
unto the said party of the second part and to his heirs  
and assigns forever all that piece and parcel of land situate  
lying and being in the County of Madison State of  
Iowa and particularly describe as follows Beginning at the  
North west corner of the South West quarter (4) of section No  
Thirty six (36) Township No Seventy six (76) North of Range  
No Twenty seven (27) West of fifth (5<sup>th</sup>) Principal Meridian  
running South twelve rods thence East parallel with North  
line of said Quarter forty rods thence North twelve rods to  
the North line of said Quarter thence West along the West line  
of said Quarter forty rods to the place of beginning also that  
other certain other piece or parcel of land situated in said  
County of Madison State of Iowa and describe as com-  
mung at the north East corner of South East Quarter (364)  
of section thirty five (35) Township and Range above men-  
tioned and being a piece of land two acres square in the corner  
of said Quarter section Together with all land singular the  
tenements hereditaments and appurtenances therunto belonging  
or in any wise appertaining and the reversion and reversions  
remainders and remainders rents issues and profits thereof  
And also all the estate right title interest dower and right  
of dower property possession claim and demand whatsoever  
as well in law as in equity of the said party of the first part  
of in or to the above described premises and every part and  
parcel thereof with the appurtenances to have and to hold  
Held all and singular the above mentioned and described  
premises together with all the appurtenances unto the said

party of the second part his heirs and assigns for ever  
and the said party of the first part their heirs the said  
premises in the quiet and peaceable possession of the said party

whomsoever lawfully claiming or to claim the same shall and will  
Warrant and by these presents forever defend
