Know all Men by these Presents, That we, Patrick Geddy and Gentilia Geddy, wife of the said Patrick Geddy, of Madison County and State of Iowa, in consideration of the sum of Two Thousand and Five Hundred ¹⁰⁰ Dollars, in hand paid, by James Monaghan of Madison County, and State of Iowa, do hereby **Sell and Convey**, unto the said James Monaghan,

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

The South West quarter ($\frac{1}{4}$) of the North East quarter ($\frac{1}{4}$) & the South East quarter ($\frac{1}{4}$) of the North West quarter ($\frac{1}{4}$) and the North East quarter ($\frac{1}{4}$) of the South West quarter ($\frac{1}{4}$) & the North West quarter ($\frac{1}{4}$) of the North East quarter ($\frac{1}{4}$) of the South East quarter, the West half ($\frac{1}{2}$) of the South West quarter ($\frac{1}{4}$) of the North West quarter ($\frac{1}{4}$) of the South East quarter ($\frac{1}{4}$) and the West half ($\frac{1}{2}$) of the West half ($\frac{1}{2}$) of the South West quarter ($\frac{1}{4}$) of the South East quarter ($\frac{1}{4}$) and ten ($\frac{1}{2}$) acres off of the middle of the West side of the East half ($\frac{1}{2}$) of the West half ($\frac{1}{2}$) of the South East quarter ($\frac{1}{4}$) and four ($\frac{1}{4}$) acres in the said South East quarter ($\frac{1}{4}$) bounded and described as follow to wit: commencing at a point thirteen & one third rods ($\frac{3}{4}$) North of a point in the South line forty (40) rods West of the South East corner and running thence West forty (40) rods then North ten & two thirds ($10\frac{2}{3}$) rods to the place of beginning all in Township number Seventy six (76) North of Range number twenty eight (28) West of $\frac{5}{6}$ P.M. and in section number eleven (11) of said Township. And containing one hundred and fifty nine (159) acres more or less.

And we hereby covenant with the said James Monaghan

that we hold said premises by good

and perfect title, that we have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever. And we covenant to warrant and defend the said premises against the lawful claims of all persons whomsoever; and the said Gentilia Geddy hereby relinquishes her right of dower in and to the above described premises.
