of Madison County and State of Iowa

do hereby

Sell and Convey, unto the said

Joel Clanton

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

Twenty two (22) acres off of the East side of the South East quarter ($\frac{1}{4}$) of the South West quarter ($\frac{1}{4}$) of section Four (4) and Twenty eight acres of the North East quarter ($\frac{1}{4}$) of the North West quarter ($\frac{1}{4}$) (scapping out of the North West corner of said quarter section twelve acres) and thirteen acres in the South part of the North West quarter ($\frac{1}{4}$) of the North West quarter ($\frac{1}{4}$) and ten acres in the South West corner of the South West quarter ($\frac{1}{4}$) of the South East quarter and two acres in the North West quarter ($\frac{1}{4}$) of the North East quarter ($\frac{1}{4}$) bounded as follows to wit beginning at the North West corner of said quarter section thence South thirty-two rods thence East ~~to~~⁽¹⁰⁾ rods thence North thirty-two rods thence West ten rods to the place of beginning all of section Nine (9) township forty-five North of Range twenty six containing forty-five acres more or less And *I* hereby covenant with the said *Joel Clanton*

that *I* hold said premises by good and perfect title, that *I* have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever. And *I* covenant to warrant and defend the said premises against the lawful claims of all persons whomsoever; and the said Sorana Clanton, the executrix of the instrument hereby relinquishes her right of dower in and to the above described premises.
