Know all Men by these Presents, That we *N. W. Menger & Jane*
Me Menger & John White
 of Madison County and State of Iowa in consideration of the sum of
Eight Hundred Dollars, in hand paid, by
Rhoda Hemphley of Madison County, and State of
 Iowa do hereby **Sell and Convey**, unto the said
Rhoda Hemphley

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:
 Twenty acres bounded and described as follows to wit commencing at
 the North East corner of section number two running thence South
 one hundred rods thence West thirty two (32) rods thence North one
 hundred rods thence East thirty two (32) rods to the place of beginning,
 also five (5) acres described and bounded as follows viz commencing at the
 North East corner of the North West Quarter of the South East Quarter of section
 number eleven running thence South thirty six rods thence West five rods
 and five eighths (5⁷/₈) thence North thirty six rods thence East five and five eighths
 (5⁷/₈) rods to the place of beginning all in Township seventy five Range
 Twenty eight

 described premises.
