This indenture made this seventh 7th day of September in the year of our Lord one thousand eight hundred and sixty four Between John Walton of the county of Peoria and state of Illinois and Mary Walton his wife of the same place of the first part and Nathaniel Walton of the county of Peoria and state of Illinois of the second part Witnesseth that the said party of the first part for and in consideration of the sum of One Hundred and fifty dollars in hand paid by the said party of the ~~second~~ part the receipt whereof is hereby acknowledged have granted bargained and sold and by these presents do grant bargain and sell unto the said party of the second part his heirs and assigns all the following described lots pieces or parcels of land situated in the county of Madison and state of Iowa to wit The South East Quarter of the North west Quarter of section Number Four (4) in Township Number Seventy four (74) North of Range Twenty Eight & West containing Forty Acres more or less together with all ~~and~~ singular the hereditaments and appurtenances thereto belonging or in any wise appertaining and the reversions and reversions remainder and remains rents issues and profits thereof and all the estate right title interest claim and demand whatsoever of the said party of the first part either in law or equity of in and to the above bargained premises with the hereditaments and appurtenances to have and to hold the said premises above bargained and described with the appurtenances unto the said party of the second part his heirs and assigns forever and the said John Walton and Mary Walton party of the first part hereby expressly waive release and relinquish unto the said party of the second part his heirs executors administrators and assigns all right title claim interest and claim whatever in and to the above described premises and each and every part thereof which is given by or results from all laws of this state pertaining to the exemption of homesteads and the said John Walton and Mary Walton party of the first part for their heirs executors and administrators does covenant grant bargain and agree to and with the said party of the second part his heirs and assigns that at the time of the sealing and delivery of these presents they were well seized of the premises above conveyed as a good sure perfect absolute and indefeasible estate of inheritance in law in fee simple and have good right full power and lawful authority to grant bargain sell and convey the same in manner and form aforesaid and that the same are free and clear from all former and other grants bargains sales liens taxes assessments and incumbrances of what kind or nature so ever and the above bargained premises in the quiet and peaceable possession of the said party of the second part his heirs and assigns against all and every person or persons lawfully

claiming or to claim the whole or any part thereof
the said party of the first part shall and will warrant
and forever defend In witness whereof the said party of
