Robt. W. Lewis,

Henry Pope.

Know all men by these presents that I, Robt. W. Lewis, of the County of Jefferson and State of Kentucky, of the first part, for and in consideration of Eight Hundred Dollars, lawful money of the United States, of America, to me in hand by Henry Pope of the County of Knox, State of Illinois of the second part, the receipt whereof is hereby acknowledged have granted, bargained, sold, transferred, conveyed, and released, and by these presents do grant, bargain, sell, transfer, convey, and release unto the said Henry Pope, party of the second part, his heirs and assigns, the following described property, viz: Lying and being in the County of Madison Co and State of Iowa, and thus further described, viz: (S. W. $\frac{1}{4}$ of N. E. $\frac{1}{4}$) South west quarter of North east quarter, also the North West quarter (N. W. $\frac{1}{4}$) of Section Number (29) Twenty nine, in township No. 77 (Seventy seven) North of Range No. 26 (Twenty six) West, containing Two Hundred (200) acres, also ten (10) off the West side of the South West $\frac{1}{4}$ (South West quarter) of the (S. W. $\frac{1}{4}$) South West quarter, of Section No. 10 (ten) Township No. 76 (Seventy six) North and Range 26, (Twenty six) West, making in all Two Hundred and ten (210) acres, together with all and singular, the rights, members, hereditaments, privileges, improvement and appurtenances to the same belonging, or in any wise incident or appertaining, To have and to hold all and singular the premises above mentioned, together with the improvements thereon, and the appurtenances thereto belonging, and appertaining unto the said Henry Pope, party of the second part, his heirs and assigns forever. And I do bind myself, heirs, executors and administrators, to warrant and defend all and singular the said premises and its improvements, &c, unto the said Henry Pope, his heirs and assigns against every person lawfully claiming, or to claim the same, or any part thereof.
