 the North East quarter (1/4) of the North West quarter of section No (21)  
 twenty one and the North East (1/4) quarter of the South East 1/4 quarter  
 of section No (20) twenty Township No (74) seventy four Range No  
 (27) Twenty seven West And We hereby covenant with the said Thomas  
 W Longshore & William Cornelison that we hold said premises by good  
 and perfect title that we have good right and lawful authority  
 to sell and convey the same that they are free and clear of all  
 liens and incumbrances whatsoever And we covenant to warrant  
 and defend the said premises against the lawful claims of all persons  
 whomsoever and the said Agatha McBeants hereby relinquishes her  
 right of dower in and to the above described premises
