**Know all Men by these Presents,** That we W. W. McKnight and Hannah McKnight his wife, C. D. Bevington and Eliza Bevington his wife, and J. J. Hutchings and Mary Hutchings his wife, all of Madison County and State of Iowa do hereby sell and convey in consideration of the sum of One thousand and five hundred dollars <sup>100</sup> Dollars, in hand paid, by The National Bank of Winterset of Madison County, and State of Iowa do hereby **Sell and Convey**, unto the said The National Bank of Winterset the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

The North two thirds ( $\frac{2}{3}$ ) of Lot number Seven (7) in Block number Eighteen (18) in the Original town plat of the City of Winterset, except Sixteen (16) feet off the West end of said Lot Reserved for an Alley.

And we hereby covenant with the said The National Bank of Winterset do hereby sell and convey that we hold said premises by good and perfect title, that we have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever.
