**Know all Men by these Presents,** That we Samuel McConkey & Hannah A. McConkey his wife, of Madison County and State of Iowa, in consideration of the sum of Dollars Sixty <sup>100</sup> Dollars, in hand paid, by Jeremiah Dooley of Madison County, and State of Iowa do hereby **Sell and Convey**, unto the said Patrick Dooley

the following described premises, situate in the County of Madison, and State of Iowa, to-wit: Seven Acres off of the East end of Twelve Acres of Land Situated in the North East corner of the South West quarter of the North West quarter of Section No Sixteen (16) in Township No Seventy six (76) North of Range No Twenty six (26) West of the 5<sup>th</sup> P.M. Iowa, bounded as follows; Commencing at a Stake Thirty two (32) Rods East on the Section line from the North West corner of the aforesaid Section, Running thence East on the said line Eleven (11) Chains and Ninety two (92) links thence South Ten (10) Chains and Six (6) links, thence West Parallel with the Section line Eleven (11) Chains and Ninety two (92) links, thence North Ten (10) Chains and Six (6) links to the place of beginning

And we hereby covenant with the said Patrick Dooley that we hold said premises by good and perfect title, that we have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever.
