Whereas the Board of Supervisors of Madison County and State of Iowa at the January Session of their body held on the 2nd day of January A.D. 1864 were satisfied that the said County of Madison had heretofore sold and by proper deed conveyed to George Hornbuck Senior Lot number seven in Block number Eighteen in the Original Town Plot of the Town of Winterset said County and whereas said deed of conveyance was never recorded upon the records of the Recorder of Deeds of said County And whereas the said deed of conveyance has been lost and the title to said lot remains of record in said County and whereas the said Board of Supervisors of said County at their meeting aforesaid and on the 24th day of January A.D. 1864 direct their Clerk in the name of said County and their name to execute acknowledge and deliver to said George Hornbuck Senior a Quit Claim Deed for said Lot Quitclaiming to said George Hornbuck Senior all the right title and interest of said County in and to said estate Wherefore Renew all men by these presents that the said County of Madison in the State of Iowa and the said Board of Supervisors of said County By M. R. Redrick Clerk of the District Court of said County and ex officio Clerk of said Madison County and of the said Board of Supervisors in consideration of the premises herein before recited and the further sum of one dollar to the said County in hand paid by the said George Hornbuck Senior hath granted bargained sold remise Quit Claimed and by these presents doth grant bargain sell remise and Quitclaim unto the said George Hornbuck Senior and unto the heirs and assigns of the said George Hornbuck Senior forever Lot No seven (7) in Block Number eighteen (18) in the original plot of the ^{Town} City of Winterset in the County of Madison and State of Iowa together with all and singular the estate right title interest claim or demand of the said County of Madison either in law or equity
