 A.D. 1864 was satisfied that the said County  
 of Madison had heretofore sold and by proper deed conveyed to  
 Daniel Campbell Lot No Six (6) in Block No Twenty four (24) in  
 the Original Town of Winterset said County and State and where  
 as said deed of conveyance was never recorded upon the records of  
 the Recorder of Deeds of said County and Whereas the said deed has  
 been lost and the title to said Lot remains of Record in said County.  
 And Whereas the said Board of Supervisors of said County at  
 their meeting aforesaid and on the 2<sup>nd</sup> day of January A.D. 1864  
 directed their Clerk in the name of said County and their name to  
 execute acknowledge and deliver to said Daniel Campbell a Quit  
 Claim Deed for said Lot Quit Claiming said Lot to the said Daniel  
 Campbell all the right title and interest of said County in  
 and to said real estate Therefore Now all men by these presents  
 the said County of Madison and State of Iowa and the said Board  
 of Supervisors of said County By McRidrick Clerk of the district  
 Court of said County and ex officio Clerk of said Madison County  
 and of the said Board of Supervisors in consideration of the sum  
 is herein before recited and the further sum of One dollar to the  
 said County in hand paid by said Daniel Campbell both granted  
 bargain and sold remise quit claimed and by these presents doth  
 grant bargain sell remise and quit claim unto the said  
 Daniel Campbell and unto the heirs and assigns of said Daniel  
 Campbell former Lot No Six (6) in Block No Twenty four (24) in the  
 Original plot of the Town of Winterset in the County of Madison  
 and the State of Iowa together with all and singular the estate  
 right title interest claim or demand of the said County either in law or equity
