

*United States Internal Revenue
Stamps to the amount of two thousand one hundred dollars attached and cancelled.*

This Indenture, made the sixth day of August in the year of our Lord one thousand eight hundred and sixty-six (1866), between THOMAS F. Withrow, a special master in Chancery, appointed by the Circuit Court of the United States in and for the State of Iowa, residing in the County of Polk, of the first part, and THE CHICAGO, ROCK ISLAND AND PACIFIC RAILROAD COMPANY, a corporation existing under and by virtue of the laws of the State of Iowa, and whose chief place of business is in Davenport in said State, of the second part:

WHEREAS, at a regular term of the Circuit Court of the United States in and for the District of Iowa, held at Des Moines in the State of Iowa, on the eleventh day of May in the year of our Lord one thousand eight hundred and sixty-six, being of the May Term of said Court, it was among other things ordered, adjudged and decreed by the said Court in certain causes then depending in the said Court, between Thomas C. Durant, Jacob S. Wetmore and Robert B. Minturn, jr., complainants, and the Mississippi and Missouri Railroad Company and others, defendants, in an original Bill in Equity; and between Edward W. Dunham, complainant, and the said Mississippi and Missouri Railroad Company and others, defendants in a cross-bill to said original bill; and between Thomas E. Walker and Franklin Haven, complainants, and the said Mississippi and Missouri Railroad Company and others, defendants, in a cross-bill to said original bill, that the mortgaged premises mentioned and set forth in the pleadings in said causes, be sold by or under the direction of the said Thomas F. Withrow, a special master commissioner appointed by the said Court, at public auction to the highest bidder for cash, at the Court House in the city of Davenport in the County of Scott and State of Iowa, at such time as said master should appoint; the said master first giving public notice of the time of such sale by advertisement thereof for four successive weeks preceding the day of sale in three newspapers published respectively in the cities of Davenport, Des Moines and Council Bluffs, in the State of Iowa:

AND WHEREAS, the said Thomas F. Withrow, special master in Chancery, and party of the first part to these presents, in pursuance of the order and decree of the said Court, did on the ninth day of July, A. D. 1866, sell at public auction at the Court House in said city of Davenport, the said mortgaged premises hereinafter particularly described, having first given the previous notice of the time and place of the said sale, with a description of the said mortgaged premises, as required by the order and decree aforesaid; at which sale the premises were sold and struck off to the said party of the second part to these presents for the sum of two million and one hundred thousand dollars; the said premises having been offered and sold in divisions or parcels as provided in the order and decree aforesaid, as follows, to-wit: The first division of said railroad for the sum of one million dollars; the Oskaloosa division thereof for the sum of three hundred thousand dollars; the second or western division thereof for the sum of six hundred thousand dollars; the west half of north-east quarter and the east half of north-west quarter of section thirty-one in township eighty of range twenty-two west, situated in Polk County, for the sum of four hundred and eighty dollars; and the remainder of the public lands included in the grant to said Mississippi and Missouri Railroad Company, as hereinafter described, for the sum of one hundred and ninety-nine thousand five hundred and twenty dollars:—the said lands having been offered in separate tracts or parcels and no bids having been made for said lands so offered separately:—the said sums being the highest sums bidden for the premises, respectively:

Now Therefore, this Indenture Witnesseth, that the said Thomas F. Withrow, special master in Chancery as aforesaid, and the party of the first part to these presents, in order to carry into effect the said sale so made as aforesaid, in pursuance of the said decree and by virtue of law, and in consideration of the premises and of the said sum of two million and one hundred thousand dollars, paid by the said party of the second part to these presents, to the said Thomas F. Withrow, special master in Chancery as aforesaid, the receipt whereof is hereby confessed and acknowledged, hath granted, bargained and sold, aliened, released, conveyed and confirmed, and by these presents doth GRANT, BARGAIN AND SELL, ALIEN, RELEASE, CONVEY AND CONFIRM unto the said party of the second part, and to its successors and assigns forever, the following described property situated and being in the State of Iowa, known as THE MISSISSIPPI AND MISSOURI RAILROAD, extending from the eastern boundary of the State of Iowa at or near the city of Davenport in Scott County by way of Iowa City to the Missouri River at or near Council Bluffs, Iowa; being the main line of said railroad now completed to Kellogg Station in Jasper County; and including also the branch of said railroad extending from Wilton in Muscatine County by way of Muscatine City to Oskaloosa in Mahaska County, and now completed to Washington in Washington County; said railroad and branch consisting of three divisions, to-wit: The first division, extending from Davenport to Iowa City and Muscatine; the Oskaloosa division, extending from Muscatine to Oskaloosa, now built as far as Washington; and the second or western division, extending from Iowa City to Council Bluffs, now built as far as Kellogg station;—the right of way, road-bed, fences, bridges and buildings, as well as all earnings, tolls and income of said road, together with the franchises, depot and station grounds, machine-shops, machinery, tools, and rolling stock consisting of locomotive engines and tenders, passenger cars, baggage cars, freight cars, dirt cars and hand cars; fuel, office furniture, ties, iron and material, supplies, stone-quarries and gravel pits, and all other property belonging to or appurtenant to the said railroad and its divisions, and owned by the said Mississippi and Missouri Railroad Company, and which is covered by or included in the mortgages foreclosed in the causes hereinbefore named:—
