sideration of Four hundred and Eight Dollars to them paid by Emerous Hazen the receipt whereof is hereby acknowledged, do hereby grant, Bargain, Sell and Convey to the said Emerous Hazen his heirs and assigns forever, the following premises situate in the County of Madison and State of Iowa, ascribed as follows, to-wit; The North half of the South East quarter of Section N^o (3) in Township N^o Seventy seven (77) North of Range N^o Twenty seven (27) West of the 5th P.M. Iowa, containing Eighty Acres more or less, and all the Estate, title and Interest of the said John Manbeck and Phoebe Manbeck either in Law or in Equity, of, in and to the said premises; Together with all the privileges and appurtenances to the same belonging, and all the rents, issues and profits thereof; To have and to hold the same to the only proper use of the said Emerson Hazen his heirs and assigns forever. And the said John Manbeck for himself and for his heirs, executors and administrators does hereby covenant with the said Emerson Hazen his heirs and assigns, that he is the true and lawful owner of the said premises, and has full power to convey the same; and that the title so conveyed, is clear, free and unincumbered; and further, that he will warrant and defend the same against all claim or claims of all persons whomsoever.
