piece or parcel of land, situated in the County of Madison and State of Iowa, to-wit; Twenty five acres off of the East side of the South West quarter  $(\frac{1}{4})$  of the South West quarter  $(\frac{1}{4})$  of Section No Five "5" Township No Seventy

six (76) North of Range No (29) Twenty nine West of the 5<sup>th</sup> P.M. Iowa.

To have and to hold the said bargained premises, together with the appurtenances thereto belonging, or in any wise appertaining unto the said Charles D. Bevington heirs and assigns forever; and we the said Amanda M. Mann & C. C. Mann (her husband) for themselves and their heirs, executors, ad-

ministrators and assigns, hereby covenanting to and with the said Charles D. Bevington his heirs, executors, administrators and assigns,
