Be it remembered, that by virtue of an execution to me directed, issued from the District Court of said County, and tested the 18th day of April A. D. 1867, in a case wherein Dominick Gilleran Plaintiff, and Stephen Maple & August Grotran Defendant, commanding me to levy the same upon the West half of North West gr. & the North East gr. of North West gr. of Sec. Nine (9) & the North East gr. of South East gr. of Sec. Five (5) and South West gr. of South West gr. of Sec. Four (4) in Township Seventy six (76) N. of Range Twenty nine (29) West, to satisfy the judgment interest and costs in the above case, and for want of sufficient personal property wherein to levy to satisfy the same, I did on the 21st day of April A. D. 1867, levy the said writ of execution upon the following described Real Estate, together with all the estate, right, title and interest of the said defendant in and to the same, to-wit;

The West half of South West gr. & the North East gr. of North West gr. of Sec. Nine (9) & the North East gr. of South East gr. of Sec. Five (5) & South West gr. of South West gr. of Sec. Four all in Tp. Seventy six (76) N. of Range Twenty nine (29) West, and after having advertised the said property for sale for four consecutive weeks, immediately preceding the day of sale hereinafter mentioned in the Winterset Madisonian a newspaper published in the City of Winterset Iowa, and posted up notices of the said sale in three public places in said County of Madison, Iowa, one of which places being in the same township in which said property is situated, and one being on the front door of the Court house in said County of Madison, the place where the last District Court of said County was held as required by law, I did on the 25th day of May A. D. 1867, between the hours of 9^o Clock A. M. and 4^o Clock P. M. of that day, proceed to sell said property, at the front door of the Court house in said County, by public outcry to the highest bidder for cash, the same being offered for sale in separate parcels, the North West gr. of the North West gr. of Section Nine (9) Township Seventy six (76) Range Twenty nine (29) and John Rees then and there bid for the North West gr. of the N.  right, title and interest which the said Stephen Maple & August
 Grotrian had on the 18th day of April A.D. 1867, or at any time
 afterwards, or now has, in and to all the above mentioned prop-
 erty, to have and to hold the same unto the said John Rees forever,
 as fully as I, the said J. F. Brock Sheriff aforesaid, and under
 the authority aforesaid, might, could or ought to sell and
