March in the year of our Lord One thousand Eight hundred and Sixty eight, Between

Henry H. Horvey and Nancy S. Horvey his wife of Marengo Mc Henry County and State of Illinois party of the first part, and Andrew J. Taylor of Thomson in the town of York in the County of Carroll and State of Illinois party of the second part,

Witnesseth, That the said party of the first part, for and in consideration of the sum of Two hundred and fifty dollars in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, and the said party of the second part, forever released and discharged therefrom, has Remised, Released, Sold, Conveyed and Quit Claimed, and by these presents doth Remise, Release, Sell, Convey and Quit Claim, unto the said party of the second part, his heirs and assigns forever, all the right, title, interest, claim and demand which the said party of the first part hath in and to the following described lot, piece, or parcel of land, to-wit:

Situated in the County of Madison and State of Iowa, and known and described as follows, to-wit;

The North East quarter of Section Nineteen in Township Seventy four Range Twenty six, Containing One hundred and六十 Acres more or less, all in Madison County and State of Iowa. —

To have and to hold the same, Together with all and singular the appurtenances and privileges therunto belonging, or in any wise therunto appertaining; and all the estate, right, title, interest and claim whatever of the said party of the first part, either in law or equity, to the only proper use, benefit and behoof of the said party of the second part his heirs and assigns forever. — And the said Henry S. Horvey and Nancy S. Horvey his wife, party of the first part hereby expressly waive, release, and relinquish unto the said party of the second part, his heirs, executors, administrators and assigns, all right, title, claim, interest and benefit whatever, in and to the above described premises, and each and every part thereof, which is given by or results from all laws of this State pertaining to the Exemption of Homesteads.

And the said party of the first part, for himself and his heirs, executors, and administrators, doth covenant, promise and agree, to and with the said party of the second part, his heirs, executors, administrators and assigns, that he hath not made, done, committed, executed, or suffered any act or acts, thing or things, whatsoever, whereby, or by means whereof,
