Know all to whom these presents shall come; Dominick of Madison County, State of Iowa, Guardian of the person and property of Mary Ellen Ryan minor sends greeting; Whereas she said Dominick Gilleron Guardian as aforesaid, heretofore, to wit, at the January session A.D. 1868 of the County Court of Madison County and State of Iowa, made application to the said court, to sell - The North West qr. of the South West quarter of Section four (4) Township Seventy six (76) Range Twenty nine (29) West of 5<sup>th</sup> P.M. - And whereas, Notice of said application was duly and personally served upon said minor according to law; And whereas also, at the said January term A.D. 1868 of said County Court, the said Dominick Gilleron in his capacity of Guardian aforesaid was, <sup>ordered and</sup> empowered to sell said lands.

And whereas also, The said Guardian has given the Bond with securities required by law. - And whereas also, The said Guardian has sold the Real Estate hereinafter described, (being the whole of the said Real Estate which the said Guardian was empowered to sell by said order of said County Court) to Leonidas Renshaw of Madison County in the State of Iowa, for the sum of Four hundred and Twenty six  $\frac{67}{100}$  Dollars. - Now therefore, Know ye, That I, the said Dominick Gilleron in my capacity of Guardian aforesaid, by virtue of the authority vested in me by said County Court, and in pursuance of the said order of said Court; in consideration of the said sum of Four hundred and Twenty six  $\frac{67}{100}$  dollars, to me paid by the said Leonidas Renshaw (the receipt whereof I hereby acknowledge) do by these presents grant, bargain, sell and convey unto the said Leonidas Renshaw and to his heirs and assigns forever, the following described tracts of Real Estate, lying and being situated in the County of Madison, and State of Iowa, to wit;

The North West quarter of the South West quarter of section No Four (4) Township 76, Range 29 - West of 5<sup>th</sup> P.M. -

To have and to hold, the said described premises unto the said Leonidas Renshaw his heirs and assigns forever.

And I the said Dominick Gilleron for myself, my executors and administrators do hereby covenant with the said Leonidas Renshaw his heirs and assigns, that in making the said sale, I have in all things observed and complied with all the requisitions of the law, and that as guardian as aforesaid, I will Warrant and defend the above granted premises to the said Leonidas Renshaw against the
