ises situate in the State of Iowa, viz:

South East quarter of Section Fourteen (14) Township
Seventy seven (77) Range Twenty seven (27) W. of the lands made subject
to sale at Fort Des Moines, Iowa, containing one hundred & sixty acres more or less,
and all the Estate, Title and Interest of the said John Manbeck and Phoebe
Manbeck either in Law or in Equity, of, in and to the said premises; Together
with all the privileges and appurtenances to the same belonging, and all the rents,
issues and profits thereof; - To have and to hold the same to the only proper use of
the said Jonathan Smith his heirs and assigns forever. - And the said
John Manbeck for himself and for his heirs, executors and administrators,
does hereby covenant with the said Jonathan Smith his heirs and assigns, that
he is the true and lawful owner of the said premises, and has full power to convey
the same; and that the title; so conveyed, is clear, free and unencumbered, and
