And Whereas Also, The said Guardian has sold the Real Estate herein-after described, (being only a part of the said Real Estate which the said Guardian was empowered to sell by said order of said County Court,) to Ira C Walker of Madison County, in the State of Iowa, for the sum of Two hundred and ten dollars. — Now Therefore, Know Ye, that I, the said A W Huberson in my capacity of Guardian as aforesaid, by virtue of the authority vested in me by said County Court, and in pursuance of the said order of said Court, in consideration of the said sum of Two hundred and ten dollars, to me paid by the said Ira C Walker (the receipt whereof I hereby acknowledge,) do by these presents grant, bargain, sell and convey unto the said Ira C Walker, and to his heirs and assigns forever, the following described tracts of Real Estate, lying and being situated in the County of Madison, and State of Iowa, to wit;
