 presents does Remise, Release, Sell, Convey and Quit Claim  
 unto the said party of the second part, his heirs and assigns  
 forever, all the right, title, interest, claim and demand which  
 the said party of the first part have in and to the following  
 described lot, piece, or parcel of land, situated in the County  
 of Madison, and State of Iowa, to-wit:
