Know all Men by these presents,

That I, Geo. R. Tanner of Wilmington in the County of Wincham and State of Vermont, in consideration of Five hundred \$500.00 dollars, paid to my full satisfaction by Horace S. Tanner of Wilmington in the County of Wincham and State of Vermont, by these presents, freely give, grant, bargain, sell and convey to him and his heirs and assigns forever, an Undivided half of a certain piece of land in the County of Madison and State of Iowa, described as follows, viz;

And known as being a part of the West half of the South East quarter of Section Thirty six (36) in Township Seventy six (76) and Range Twenty eight (28) fifth principal Meridian, now particularly described as follows, to wit; - Commencing at a point in the South line of the said West half (1/2) Thirty seven & one hundred and thirty five one thousandths ($37 \frac{135}{1000}$) West of the South East corner of the same, running thence North parallel with the East line of said West half Twenty five & twenty ninth one hundredths ($25 \frac{29}{100}$) rods, thence West and parallel with said South line Six & Thirty-two one hundredth ($6 \frac{32}{100}$) thence South parallel with said East line, Twenty-nine & seventy nine one hundredth ($29 \frac{79}{100}$) rods, to said South line, thence East along said South line Six & thirty two one hundredths ($6 \frac{32}{100}$) rods, to the place of beginning (One half Acre). - Also the South West quarter of the South East quarter of Section No Thirty six (36) Township No Seventy six (76) of Range Twenty eight (28). Commencing at a point on the South line of said quarter, Six chains & thirty two & one fourth ($32 \frac{1}{4}$) links West of the South East corner of the same, to run thence West along said line Three chains & (16 & 1/8) links, thence North Six chains & ($32 \frac{1}{4}$) links, thence East three chains & (16 & 1/8) links, thence South Six chains & ($32 \frac{1}{4}$) links to the place of beginning, containing two Acres."

Also, the South East quarter of the South East quarter of Section No Two (2) in Township Seventy five (75) North of Range No. Twenty eight (28) West of the fifth principal meridian, containing forty Acres more or less, and being the same land conveyed to C. W. Ripley & G. R. Tanner by Wm Bolinger & wife April 30th 1866.

To have and to hold said granted premises, with all the privileges and appurtenances thereof, to him and his heirs and assigns forever, And further I, the said Geo. R. Tanner for myself and my heirs, executors and administrators, covenant with the said Horace S. Tanner and his heirs and assigns, that until the sealing of these presents, I am the sole owner of the premises, and have good right and title to convey the same
