Engenbright & Betts

423 That we John R. McCall and Mary Y. McCall
of the County of Madison and State of Iowa in consideration of the
sum of six thousand dollars in hand paid by William A. Engenbright
and Joseph Betts both of Madison County and State of Iowa, do hereby
sell and convey unto the said William A. Engenbright and Joseph Betts
the following described premises, situated in the County of Madison and
State of Iowa, to-wit:

The Undivided one half of a parcel of land, commencing on
the East-line of the S.E. quarter(1/4) of the N.E. quarter(1/4) of Section Twenty three (23)
Township (75) Seventy five, Range Twenty six (26) parallel with the South side
of Main Street in the Village of St. Charles in the County of Madison and
State of Iowa - thence running North on said East-line twenty (20) rods, thence
West sixteen (16) rods, thence South twenty (20) rods to the South side of the lane
running West from said Village, thence East to the place of beginning,
Containing two Acres. — Also the Undivided one half of a parcel of
land lying in the North East quarter(1/4) of the North West quarter(1/4) of the
South West quarter(1/4) of Section No Twenty three (23) in Township No Seventy five
(75) North of Range Twenty six (26) West, commencing at the North East corner
and running South forty (40) rods, thence West twenty four (24) rods, thence
North forty (40) rods, thence East twenty four (24) rods to place of beginning,
Containing six (6) Acres. — And we hereby covenant with the said
William A. Engenbright and Joseph Betts that we hold said premises by good
and perfect title, that we have good right and lawful authority to sell and convey
the same that they are free and clear of all liens and incumbrances whatever.
And we covenant to warrant and defend the said premises against the lawful

singuishes her right of dower in and to the above described premises.
