 Johnston, Catherine Johnston, Henrietta Johnston, Eliza Johnston, Nancy Ellen  
 Johnston, minor children and heir at law of John Johnston deceased sends  
 greeting. Whereas, the said J.W. Johnston Guardian as aforesaid, hereto  
 fore, had; at the November session A.D. 1867 of the County Court of  
 Madison and State of Iowa, made application to the said Court to  
 sell among other lands the following tract, commencing forty nine rods  
 (49) north of the south west corner of the south east quarter of Section Twenty  
 Township seventy five Range Twenty six A. S. P. M., thence East One hundred  
 and sixty rods, thence north five rods, thence west One hundred and sixty  
 rods, thence south five rods to the place of beginning - And whereas,  
 notice of said application was duly and personally served upon said  
 minor according to law; And whereas, also, at the said November  
 term, A.D. 1867 of said County Court, the said J.W. Johnston in his  
 capacity of Guardian aforesaid, was ordered and empowered to sell

 required by law; And whereas, also, the said guardian has sold the Real

Greger, his heirs and assigns forever. And I, the said J.W. Johnston for myself, my executors and administrators, do hereby covenant with the said Samuel M. Greger, his heirs and assigns, that in making the said sale, I have in all things observed and complied with all the requisitions of the law; and that as guardian aforesaid, I will warrant and defend the above granted premises to the said Samuel M. Greger, against the lawful claims of said minors, and all persons claiming or to claim the same, through or under them, or either of them. - In Testimony Whereof, I have hereunto set my hand and seal, this second day of October AD 1868.
