 the first part, and Emanuel Faust of the County of Warren in the State
 of Iowa, parties of the second part, Witnesseth, that the said parties of the
 first part, in consideration of the sum of One Hundred & Sixty Dollars,
 to them paid by the said party of the second part, the receipt of which is
 hereby acknowledged, does by these presents, Grant, Bargain and Sell, Convey
 and Confirm, unto the said party of the second part, his heirs and assigns,
 the following described lots, tracts, or parcels of land, lying, being and situate
 in the County of Madison and State of Iowa, To-wit:

All the North East quarter of the North East quarter of Section No
 Twenty five (25) in Township No 25, South, Range No 26, Treaty Six
 containing Forty acres more or less, To Have and To Hold the prem-
 ises aforesaid, with all and singular the rights, privileges, appurtenances
 and immunities thereto belonging, or in any wise appertaining, unto
 the said party of the second part, and unto his heirs and assigns, forever,
 the said Hamilton Moore & Rebecca Moore, his wife, hereby covenanting that
 they are lawfully seized of an indivisible estate in fee in the premises
 herein conveyed, that they have good right to convey the same, that the
 said premises are free and clear of any encumbrances done or suffered by
 them or those under whom they claim, and that they will Warrant and
 defend the title to the said premises unto the said party of the second
 part, and unto their heirs and assigns forever, against the lawful claims and
 demands of all persons whomsoever, In Witness Whereof, the said parties of the
 first part have hereunto set their hands and seals, the day and year first above written

 instrument, upon an examination separate and apart from her husband, acknowledged
 that she executed the same, and relinquishes her dower in the real estate therein mentioned,
 free and without any reservation, or undue influence of her said husband, In Testimony Whereof,
