Know all Men by these presents,

That Isaac Stewart and Nancy Stewart wife of the said Isaac Stewart of the County of Newton in the State of Missouri, have this day, for and in consideration of the sum of Two thousand dollars, to them, the said Isaac Stewart and Nancy Stewart in hand paid, by Benjamin Dunnagan of the County of Newton, in the State of Missouri, the receipt whereof is hereby acknowledged, Granted, Bargained and Sold, and by these presents do Grant, Bargain, Sell and Convey unto the said Benjamin Dunnagan the following described tracts or parcels of land, situate in the County of Madison, in the State of Iowa, that is to say, a certain tract,

Commencing at a point forty four (44) rods South of the North East corner of Section number One (1) in Township number Seventy five (75), Range Twenty eight (28), thence West Sixteen (16) rods to a point parallel with the East side of Polk Street in the town of Winterset in said County, thence South Seventy five (75) Rods, thence East Sixteen (16) rods, to the East line of said Section number One (1), thence North Seventy five (75) rods to the place of beginning containing Seven and one half ( $7\frac{1}{2}$ ) acres of land. —

To have and to hold the premises hereby conveyed, with all the rights, privileges and appurtenances thereto belonging, or in anywise appertaining, unto the said Benjamin Dunnagan, and to his heirs and assigns, forever, they the said Isaac Stewart and Nancy Stewart hereby covenanting to and with the said Benjamin Dunnagan his heirs and assigns, for themselves, their heirs, executors and administrators to warrant and defend the title of the premises hereby conveyed against the claim of every person whatsoever.
