I Judith Harriott of the Town of Greene,  
 and County of March, State of Illinois, of the age of forty  
 seven years, and being of sound mind and memory, do hereby  
 make publish and declare this my last will and Testament  
 in the language following: That is to say:

1<sup>st</sup> — I give and bequeath unto my daughter Mary Samantha  
 Harriott, her heirs and assigns, forever, the following described  
 tract and parcel of land situate and described as follows;

The East half of the South East quarter of Section (30)  
 Thirty of Township (N<sup>o</sup> 75) Seventy five North. of Range (28) Twenty  
 eight West, and also the North half of the South half of the  
 North East quarter of Section number (N<sup>o</sup> 31) Thirty one of  
 Township and Range aforesaid. Containing altogether Two  
 hundred (200) Acres more or less, and situate in the County of  
 Madison and State of Iowa, and being the same lands conveyed  
 to me by deed from Moses McGuinness and Mary McGuinness  
 his wife. — Also — Lot N<sup>o</sup> Thirty two (32) in the Town of  
 Marysville, Allen County, Ohio, the same conveyed to me by  
 deed from Clark J. Williams.


To have and to hold the above named premises together
