 part, and A. R. Dabney of the second part, witnesseth that the  
 said parties of the first part, for and in consideration of the  
 sum of One Hundred and Fifty Dollars, in hand paid by the  
 said party of the second part, the receipt whereof is hereby ack-  
 nowledged, have granted and sold, and do by these presents,  
 grant, bargain, sell, Convey and confirm unto the said  
 second party, his heirs and assigns, forever, the following Real  
 Estate, lying and being situated in the County of Madison  
 and State of Iowa, to-wit: The North West quarter of the  
 South East quarter of Section (13) Thirteen in Township (75)  
 Seventy five north of range (38) Twenty eight West of the 5<sup>th</sup> P.M.  
 Also the South West quarter of the South West quarter of Section  
 Nine in Township (74) Seventy four North of Range (28) twenty  
 eight West of the 5<sup>th</sup> P.M. the intention being to convey hereby  
 An absolute title in fact to Said Real Estate, including all  
 right of Homestead had therein, to have and to hold the  
 premises above described, with all the appurtenances thereto be-  
 longing, unto the said second party, his heirs and assigns, forever,  
 the said Geo B. Denison hereby covenanting for himself, his heirs,  
 executors and administrators, that the above described premises are  
 free from any incumbrance, that he has full right, power and auth-  
 ority to sell the same, and he will warrant and defend the title  
 unto the said second party, his heirs and assigns, against the claims  
 of all persons whomsoever lawfully claiming the same,  
 And the said Margaret M. Denison hereby releases and  
 extinguishes all her right of dower in and to the following de-
