of Barnie C. Redmond deceased, Lands Greeting. Whereas the
Said Rinehart Guardian as aforesaid did at the January
term A.D. 1873, of the Circuit Court of Polk County Iowa,
make application to sell the South half of the South West quarter
and the North West quarter of the South West quarter and the North
East quarter of the South West quarter of Section Twenty-Ei-
ghth and the North East quarter of the South East quarter of
Section Twenty-Nine all in Township Seventy-Six, Range
Twenty-Six in Madison County Iowa, - and whereas Notice of said
application was legally and personally served upon Said minors
according to law and whereas also at the said Term of
said Court & the said Simon Rinehart Jr. in his capacity
