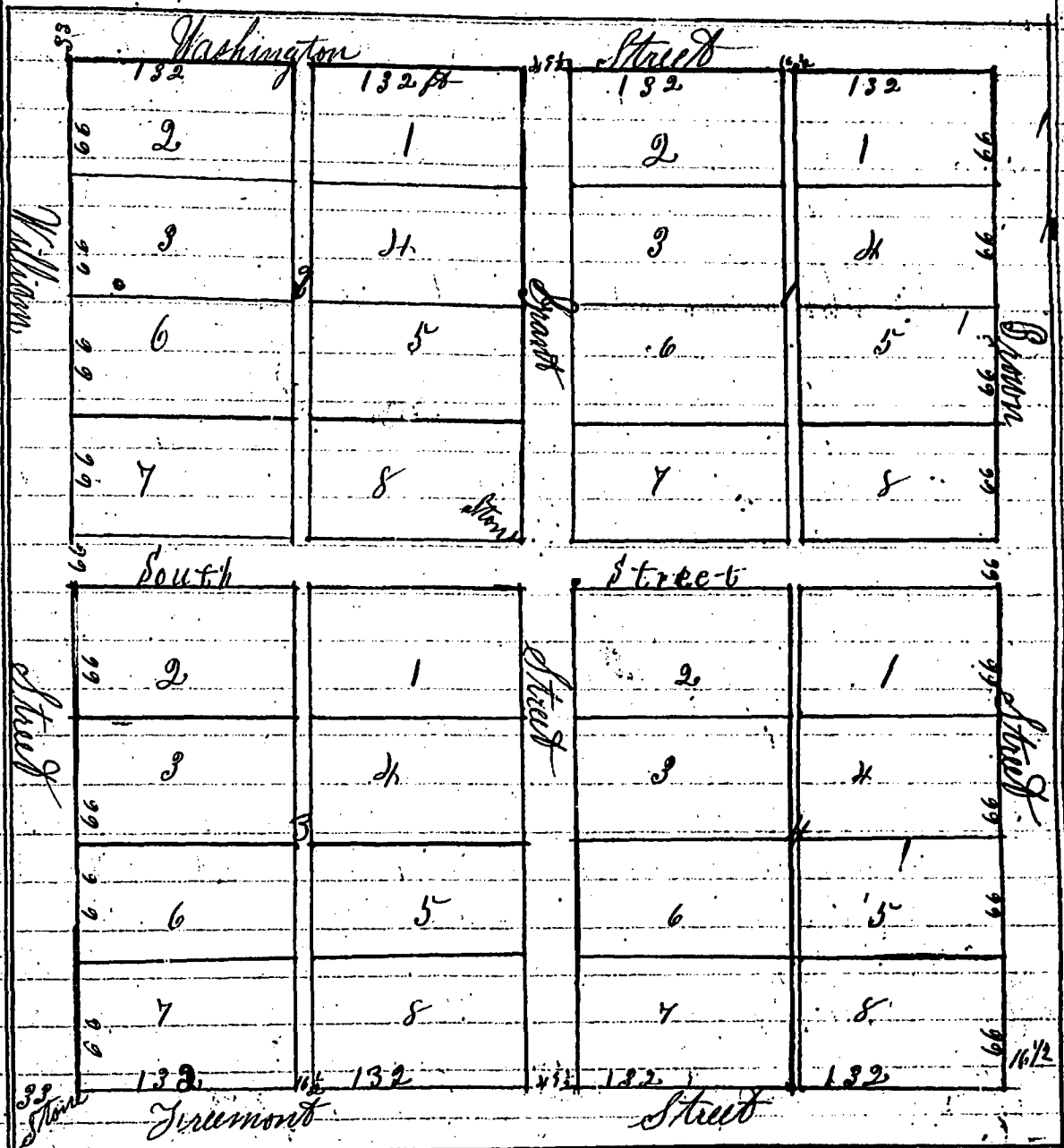

Adkison's Addition to Winterset Iowa,



Survey of an addition to the town of Winterset Madison county Iowa to be known as Adkison's Addition to Winterset Iowa Be it remembered and it is hereby certified that we A. G. Adkison and Amner Adkison and A. H. Adkison & Laura Adkison of the town of Winterset county of Madison and State of Iowa do hereby declare and make known that the plat of the said addition upon which this declaration is written is situated upon the South East quarter of the South West quarter of Section 36 Township 25 North Range 25 East bounded as follows to wit: Commencing twenty rods south of the North East corner of said above described forty acres, running thence South 40 rods; thence west forty rods; thence North 40 rods; thence east 40 rods to the place beginning. The said A. G. Adkison being the owner of the South three fourths and the said A. H. Adkison being owner of the North 1/4 of the said tract of land said addition.

divided into four Blocks each of which is 280 1/2 feet East and West and 260 North and South and each has an alley 10 1/2 feet wide passing through the center thereof from north to South and each of the said Blocks is divided into eight lots each of which said lot is 61 feet wide north and South and 132 feet long East and West and all of lots & Blocks are numbered as shown by the annexed plat the name and width and course of each street is shown correctly by said plat and we A. J. Adhison and A. H. Adhison owners & proprietors of the land upon which the said addition is situated hereby further declare that the disposition ^{thereof} as indicated by the said plat is with our consent and in accordance with our desire and the said A. J. Adhison & the said Laura Adhison hereby relinquish their right of dower to so much of said land as is therein specified as being set apart for streets and alleys.
