the following, to-wit:

Application for loans shall be upon the Association blanks. Loans may be made to installment stock nolders, not exceeding Two Hundred (\$200.00) Dollars, on each share of stock owned by the applicant, and the shares of stock used as a basis for said loan shall be assigned to the association as collateral security for said loan. The loan shall be further secured by a note or Bond, and a first Mortgage on unencumbered real estate situated in Madison County, Iowa, which property shall equal in value twice the amount of the loan after deducting from said loan the value of the shares of stock so. assigned, except, the executive committee may take a second mortgage upon real estate, where the first mortgage thereon is held by this Association, and the total amount of said mortgages does not exceed the limitation above named. Such mortgage shall provide for the payment of Attorney fees for collection, and for the payment of taxes and insult ance. The loan shall bear interest at the rate of six per cent per annum, payable in equal monthly installments before four o'clock P.W. on the last Saturday in each month, If the interest or an installment thereof, or the taxes levied upon the mortgaged prepises remain delinquent at any time for three months the note or bond and the mortgage shall become due and collectible at the option of the Leard of Directors, and said Se board may proceed to the foreglosure of said note or bond and mortgage in the manner provided by law. Delinquent interest and money advanced for the payment of taxes and insurance shall bear interest at the rate of eight per cent per annum for the time det linquent.
