Lenocker conveyed the said premises by Quit Claim Deed to Henry D. Lenocker, et al by deed dated October 8th 1880, recorded in Deed Record 15 at Page 629 thereof, in the execution of which deed the said Jacob B. Lenocker signed the same J.B. Lenocker; that the said Jacob B. Lenocker and the said J.B. Lenocker was one and the same person.

I further depose and say, that Mary E. Lenocker, one of the Grantees named in the afore said deed, Recorded in Deed Record 15 at page 629, and Mary E. Larkey one of the Grantors named in a Quit Claim Deed, of date September 22nd 1892, Recorded in Deed Record 29 at page 507, and Mary E. Purdun, referred to in said deed Quit Claim Deed so recorded in Deed Record 29 at Page 507 thereof, is one and the same person, and that, prior to the execution of the said Quit Claim Deed by the said Mary E. Larkey as aforesaid, the said Mary E. Larkey had been duly and legally divorced from her former husband Charles F. Purdun. I further depose and say, that Henry D.
