I, James S. Lorimor of said State and County first being duly sworn upon my oath depose and say that I was well and personally acquainted with B. F. Lorimor who together with his wife conveyed the E¹/₂ SECTION 22, except as follows, Commencing 20 rods South of the center of said Section, thence East 39 rods, thence North 115 rods, thence West 39 rods, thence South 115 rods to place of beginning, & SW¹/₄ NW¹/₄ & 42 rods wide off of the North side of the W¹/₂ SW¹/₄ & 12 rods in width off of the North end of the E¹/₂ SW¹/₄ (23) & S¹/₂ SE¹/₄ (15) except N¹/₂ SW¹/₄ SE¹/₄ thereof, & NE¹/₄ NW¹/₄ (22), except 10 acres in a square in the South East corner thereof, all in 75-28 on August 21st, 1885 to N.W. Munger and I well and personally know that he was the same an' identical person as B.F. Lorimore to whom the West 5 1/2 acres of the SW¹/₄ SW¹/₄ SE¹/₄ (15) & South 26 rods of the North 38 rods of NW¹/₄ SW¹/₄ (23), except 2 rods square out of the North West corner thereof, all in 75-28, and the same and identical person as Benjamin F. Lorimor to whom the E¹/₂ (22) & S¹/₂ SE¹/₄ (15) & SW¹/₄ NW¹/₄ (23), all in 75-28 was conveyed, and I further depose and say that B.F. Larimer and M.E. Lorimor who on March 1st, 1887 conveyed the SW¹/₄ SW¹/₄ SE¹/₄ 15-75-28 to N.H. James and Levi Supe were on that date husband and wife and that the said B.F. Larimer was the same and identical person to whom said land was conveyed, and that B.F. Lorimor and M.E. Lorimor who on September 9th 1887 conveyed 3 acres of the NW part of the SW¹/₄ NE¹/₄ 22-75-28 were on that date husband and wife, and I further depose and say that I was well and personally acquainted with A.C. Larmor who together with his wife conveyed the E¹/₂ 22 & S¹/₂ SE¹/₄ (15) & SW¹/₄ NW¹/₄ 23-75-28 to Benjamin F. Lorimor on April 2nd, 1886 and I well and personally know that he was the same and identical person as Andrew C. Lorimore to whom said land was conveyed, and I further state that A.W. Lorimore who together with his wife conveyed the said land to Andrew C. Lorimore on October 28th, 1884 was the same and identical person as A.W. Lormor to whom said land was conveyed.
