I, W. W. McKnight a resident of the State and County aforesaid being first duly sworn upon my oath depose and say that I was well and personally acquainted with the persons whose names are below mentioned and of my own personal knowledge know the facts as herein set forth. That Alfred T. Marshall, grantee in deed recorded in Deed Record "A" on page 272 of the records of Madison County Iowa, is the same and identical person as A. S. Marshall, grantor in deed recorded in Deed Record "D" page 128 of said records.

That Alexander F. Cassidy, grantee in deed recorded in Deed Record "D" on page 129; A. M. Cassidy grantor in deed recorded in Deed Record "D" on page 357; A. M. Cassidy, one of the grantors in plat of Laughridge & Cassidy's Addition to Winterset, Iowa, recorded in Deed Record "E" on page 129, and A. M. Cassidy one of the grantors in deed recorded in Deed Record "E" on page 136, are all one and the same and identical person; his correct name being Alexander M. Cassidy.

That A. M. Cassidy and Lucinda Cassidy were husband and wife on November 13th 1855 at which time they conveyed to Wm. Loughridge as shown by deed recorded in Deed Record "D" on page 357 of said records.

That Wm. Loughridge, grantee in deed recorded in Deed Record "D" on page 257; William Loughridge grantee in deed recorded in Deed Record "L" on page 147; Wm. Laughridge one of the grantors in plat of Laughridge & Cassidy's Addition to Winterset, Iowa, and Wm. Loughridge one of the grantors in deed recorded in Deed Record "E" on page 136, of said records, are all one and the same identical person.

That Wm. Laughridge was a single and unmarried man on May 18th 1856 when he joined in the plat of Laughridge and Cassidy's Addition to Winterset, Iowa. That the said Wm. Loughridge was also a single and unmarried man on June 23rd 1856, at which time he together with A. M. Cassidy and wife conveyed to David Lamb as shown by deed recorded in Deed Record "E" on page 136 of said records.

That David Lamb was a single and unmarried man on July 23rd 1856 at which time he conveyed to John Hinkle as shown by deed recorded in Deed Record "E" on page 157 of said records. That John Hinkle, grantee in deed recorded in Deed Record "E" on page 157, and John Henkel grantor in deed recorded in Deed Record 4 on page 281, are one and the same identical person. That I am in no way interested in making this affidavit.
