I, E. E. McCall, of said State and County first being duly sworn, upon my oath depose and say that I was well and personally acquainted with John T. Folwell who together with his wife executed a deed on May 10th, 1886 conveying to William B. Folwell the W¹/₂ SE¹/₄ 34-77-27, described as follows:-Commencing at the Southwest corner of SE¹/₄ of said Section 34, thence East 80 rods, thence North 105 rods, thence West 7 rods to the County road, thence along the line of said County road to the North line of the SE¹/₄ 34-77-27, the deed therefor being recorded on page 600 of Deed Record 24 of the records of Madison County, Iowa and I well and personally know that the said John T. Folwell was the same and identical person as John Thomas Folwell to whom Samuel Folwell conveyed the SE¹/₄ 34-77-27 on Jan. 12th, 1885, the deed therefor being recorded on page 102 of Deed Record 24 of the records of Madison County, Iowa, John T. Folwell and John Thomas Folwell to my personal knowledge being one and the same and identical person, and I further depose and say that I was well and personally acquainted with B. F. Hermon who together with his wife conveyed 2 acres in Section 34-77-27 described as follows:-commencing at the North West corner of the SE¹/₄ said Section 34, running thence South 56.65 rods, thence East 5.66 rods, thence North 56.65 rods, thence West to the place of beginning, to W. B. Folwell on October 30th, 1895, the deed therefor being recorded on page 140 of Deed Record 29 of the records of Madison County, Iowa, and I well and personally know that the said B. F. Hermon was the same and identical person as Benjamin Hircock to whom S. V. White and wife conveyed Lot 2 in Section 31-77-28 and 2 acres in Section 34-77-27 described as follows:- Commencing at the North West corner of the SE¹/₄ of said Section 34, running thence South 56.65 rods, thence East 5.66 rods, thence North 56.65 rods, thence West 5.66 rods to place of beginning by deed dated October 4th, 1886 and recorded on page 118 of Deed Record T of the Records of Madison County, Iowa Benjamin Hircock and B. F. Hermon to my personal knowledge being one and the same and identical person, and I well and personally know that B. F. Hircock who signed the above mentioned deed to W. B. Folwell was the same and identical person as Benjamin F. Herman whose name appears in the granting clause of said deed.
