Martin, the deed therefor being entered of record on page 169 of Deed Record P of the Records of Madison county, Iowa, and I well and personally know that on said date the said Robert Beckett was an unmarried man, of lawful age and competent to convey real estate, and I further depose and say that I was well and personally acquainted with Martin F. Boyles to whom Samuel A. Ross administrator of the estate of Noah Bishop, deceased, conveyed the NW $\frac{1}{4}$ SE $\frac{1}{4}$ 29-74-28 on December 8th, 1869 and I well and personally know that the said Martin F. Boyles was the same and identical person as M. F. Boyles to Bethel Mills and wife conveyed the E $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ 29-74-28 on March 4th, 1873, and I well and personally know that the said Martin F. Boyles was the same and identical person as M. F. Boyles who, together with his wife conveyed the NW $\frac{1}{4}$ SE $\frac{1}{4}$ & E $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ 29-74-28 to P. M. Boyles on March 11th, 1874, Martin F. Boyles and M. F. Boyles to my personal knowledge being one and the same and identical person, and I further depose and say that I was well and personally acquainted with Bethel Mills who together with his wife conveyed the E $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ 29-74-28 to M. F. Boyles on March 4th, 1873 and I well and personally know that the said Bethel Mills was the same and identical person as Bethlehem Mills to whom P. M. Boyles guardian conveyed the same land on March 28th, 1871 and that he was the same and identical person as Bethlehem Mills of whom P. M. Boyles was guardian on December 8th, 1869 at which time Samuel A. Ross administrator of the estate of Noah Bishop, deceased, conveyed the E $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ 29-74-28 to P. M. Boyles guardian of Bethlehem Mills, and I further depose and say that I was well and personally acquainted with Noah Bishop and with his family and I well and personally know that Weighty Phipps who is given in the registry of heirs filed in the estate of Noah Bishop, deceased, as one of his heirs is the same and identical person as Waity Phipps who was one of the defendants in a certain action in the Circuit Court of Madison county, Iowa brought by Samuel A. Ross administrator of the estate of Noah Bishop, deceased, for the sale of real estate belonging to his estate and the same and identical person as Waity Phipps who was served with notice in said action, Weighty Phipps and Waity Phipps to my personal knowledge being one and the same and identical person, and I further depose and say that I well and personally know that Elizabeth J. Hooton who is given in the registry of heirs filed in the estate of Noah Bishop, deceased, as one of his heirs is the same and identical person as Jane Hooton who was one of the defendants in the above mentioned action wherein Samuel A. Ross administrator of the estate of Noah Bishop, deceased, was plaintiff, and the same and identical person as Jane Hooton who was served with notice in said action, Elizabeth J. Hooton and Jane Hooton being one and the same and identical person, and I further depose and say that I well and personally know that Melissa Rison who is given as one of the heirs at law of Noah Bishop, deceased, in the registry of heirs filed in his estate, is the same and identical person as Melissa Rison who was one of the defendants in the above mentioned action wherein Samuel A. Ross administrator of the estate of Noah Bishop, deceased, was plaintiff, and the same and identical person as Melissa Rison who was served with notice in said action, and the same and identical person as Melissa Rison who is mentioned in said petition as one of the heirs of said Noah Bishop, Melissa Rison, Melissa Rison, Melissa Rison and Melissa Rison to my personal knowledge being one and the same and identical person, and I further depose and say that I well and personally know that John W. Bishop who is given as one of the heirs at law of Noah Bishop deceased, in the registry of heirs filed in his estate is the same and identical person as John Wesley Bishop who is one of the defendants in the above mentioned action, and the same and identical person as John Wesley Bishop who was served with notice in said action, and the same and identical person as John Wesley Bishop who is mentioned as one of the heirs of said Noah Bishop in the petition filed in the above mentioned action, John W. Bishop, John Wesley Bishop and John Wesley Bishop to my personal knowledge being one and the same and identical person, and I further depose and say that I well and personally know that Paulina Bishop who is given as one of the heirs at law of Noah Bishop, deceased, in the registry of heirs filed in his estate is the same and identical person as Paulina Bishop who is one of the defendants in the above mentioned action, and the same and identical person as Paulina Bishop who was served with notice in said action, Paulina Bishop and Paulina Bishop to my personal knowledge being one and the same and identical person, and I further depose and say that I well and personally know that Mary A. Bishop who is given as the widow of Noah Bishop, deceased, in the registry of heirs filed in his estate is the same and identical person as Mary Ann Bishop who is one of the defendants in the above mentioned action, and the same and identical person as Mary Ann Bishop who was served with notice in said action, Mary Ann Bishop and Mary A. Bishop to my personal knowledge being one and the same and identical person.
