Articles of Incorporation for a Manufacturing Company
We the undersigned do by these presents associate our selves together under and by virtue of Chapter One title nine of the Code of Iowa, and the laws Amendatory thereto do adopt the following Articles of Incorporation.

Articles I

The Name of This Corporation shall be

" The Truro Washing Machine Company"

And its principal place of Business shall be Truro Iowa, and the general nature of its business shall be the Manufacture of Washing Machines and such Articles of general use and sale as may be determined upon from time to time by the officers of said Company.

Article II

This Corporation shall commence business on the first day of May A.D. 1905 and continue Twenty years with the right of renewal unless sooner dissolved by three-fourths vote of all the Stock subscribed at a Stock holders meeting, The Capital Stock Authorized shall be ten thousand Dollars divided into Shares of One hundred Dollars each and may be increased to any sum not exceeding Twenty Thousand Dollars and all Stock subscribed shall be paid in assessments by a two thirds vote of Stock holders,

Articles III

The Officers of this Corporation shall be conducted by five Directors who shall hold their office one year and until their successors are elected & Qualified Said directors from their own number shall elect at their first meeting in each year a President, Who shall hold his office One year and until his successor is elected and qualified and said Directors shall at said Meeting elect a Secretary & Treasurer who shall hold their offices during the pleasure of said Board, and who shall give bonds to the Corporation in such sum and conditions as the Board of Directors may from time to time direct; and said Directors shall have the right to fill all vacancies occurring in the offices of said Corporation,

Article IV

The election of the Directors of this corporation shall be held at the office of the Secretary in Truro Ia, on the first Tuesday of May 1906 and on the first Tuesday of each May thereafter, at all elections and meetings of the Stock holders of this Corporation each person or Corporation shall be entitled to one vote for each share of Stock owned by such person or corporation which vote may be cast in person or by proxy Three days notice by publication in a Newspaper published in Madison Co. shall be given of all called or special meetings of Stock holders.

Article V

Real Estate, personal property, work and labor, may be taken and received for Stock at such prices and upon such terms and conditions as may be agreed upon by the Board of Directors.

Article VI

The Directors may call a meeting of the Stockholders at any time they deem it proper, and shall do so upon the written request of the Stock holders owning a majority of the Capital Stock subscribed,

Article VII

The Directors of this Incorporation until the election in May A.D. 1906 shall be H.H. Munson, E.E. Kale, L.F. Creger, D.P. Reed, & W.W. Atkinson, who shall at their

first meeting elect a President

Article VIII

The private property of the members of this Corporation shall be exempt from the liability for the debts of this corporation.

Article IX

The indebtedness of this Corporation shall not at any time exceed Five Thousand Dollars.

Article X

No Alteration or amendment shall be made to these Articles of incorporation unless the same be adopted by a majority of the Stock holders present at a meeting of the Stockholders called for that purpose.
