That Whereas, Edward E. Thompson, and I, the undersigned are the sole and only heirs-at-law of J.H. Thompson, whose name appears in the mortgage hereafter described as James H. Thompson, we being the only children of the said J.H. Thompson and Sarah E. Thompson, and that the said Sarah E. Thompson being our mother having died previous to the date of our father's death, the said J.H. Thompson; and that as an equal heir with my brother, the said Edward E. Iowa, the same being one hundred and thirty-two feet north and south and forty rods east and west.

And I hereby authorize, empower and appoint the said Edward E. Thompson to cancel said mortgage of record, and to receive and receipt for all money due and secured by said mortgage, as fully and completely and with like force and effect in law and equity as if done by me.
