I, George Snyder first being duly sworn on oath depose and say that I am the identical George Snyder, who together with my wife executed a warranty deed to the South-One-half of the Southwest Quarter (S.  $\frac{1}{2}$  of SW.  $\frac{1}{4}$ ) and Southwest Quarter of Southeast Quarter (SW.  $\frac{1}{4}$  of SE.  $\frac{1}{4}$ ) of Section Three (3); and the Northwest Quarter of the Northwest Quarter (NW.  $\frac{1}{4}$  of NW.  $\frac{1}{4}$ ) and the Northwest Quarter of the Northeast Quarter (NW.  $\frac{1}{4}$  of NE.  $\frac{1}{4}$ ) of Section Ten (10) township Seventy seven (77) North Range Twenty Nine (29) west of the 5th P.M. Iowa, to Citizens National Bank of Winterset, Iowa on the 26th. day of November A.D. 1894, which said land was subject to two \$2000.00 mortgages.

Dodge. I do depose and say that I am credibly informed that the records of Madison County, Iowa show that said mortgage to Northfield Savings Bank was subject to a mortgage for \$2000.00 to Samuel A. Dodge. That if the records so appear it is an error and should read Samuel D. Dodge. That at the date of the execution of said mortgage there was no mortgage upon said premises to Samuel A.
