McKnight, of said State and County first being duly sworn upon my oath depose and say that I am the same and identical person to whom the Sheriff of Madison County, Iowa conveyed the undivided one-half of the NW¹ SE¹ 32-76-27 on June 20th, 1863, the deed therefor being recorded on page 574 of Deed Record S. of the Records of Madison County, Iowa, and I was well and personally acquainted with W.E. Davidson mentioned in said deed and against whom Timothy S. Lull recovered a judgment for \$86.94 and I well and personally know that the said W.E. Davidson was the same and identical person as William E. Davidson to whom the whole of said NW¹ SE¹ 32-76-27 was conveyed by C.K. Lindsay, and I further depose and say that I was well and personally acquainted with C.K. Lindsay, who on September 17th, 1855 conveyed the undivided one-half of the NW¹ SE¹ 32-76-27 to William E. Davidson and I well and personally know that the said C.K. Lindsay was an unmarried man, of lawful age and competent to convey real estate on said September 17th, 1855 and I well and personally know that the said C.K. Lindsay who conveyed the said NW¹ SE¹ 32-76-27 to said William E. Davidson was the same and identical person as Christian K. Lindsay to whom Samuel B. Barker and wife conveyed the NW¹ SE¹ 32-76-27 on July 8th, 1854, and I further depose and say that I was well and personally acquainted with S.A. Mackey to whom I conveyed the NW¹ SE¹ 32-76-27 on December 14th, 1867 and I well and personally know that the said S.A. Mackey was the same and identical person as Samuel A. Mackey who together with his wife conveyed said land to Amos De Cou on December 23rd, 1867, and I further depose and say that I well and personally know that Christian K. Lindsay to whom Samuel B. Barker and wife conveyed the S¹ NE¹ 32-76-27 on July 8th, 1854 was the same and identical person as C.K. Lindsay who conveyed the undivided one-half thereof to Wm.E. Davidson on May 26th, 1855 and the same and identical person as C.K. Lindsay who conveyed the undivided one-half of the S¹ NE¹ 32-76-27 to William E. Davidson on September 17th, 1855, and I further depose and say that I well and personally know that S.A. Mackey to whom I conveyed the S¹ NE¹ 32-76-27 on December 14th, 1867 was the same and identical person as Samuel A. Mackey who, together with his wife conveyed said land to Amos De Cou on December 23rd, 1867.
