Shriver, being duly sworn depose and say: That I am a resident of Madison County Towa, and have been for more that fifty years last past, and that I was well and personally acquainted with Enos Berger, and that Enos Berger who received a patent from the State of Iowa for the West half of the N. C. d of 36-76-28 and other land, which Patent is recorded in Madison County, Iowa, Deed Record No. 31, on page 523 thereof; and the Enos Berger who on March 3rd, 1863, by warranty deed, (which is recorded in Deed Rocord K'on page 119 thereof) conveyed said land to Chas A.Gaskill; and the Enos Berger, who or March 20th 1860 by warranty deed, (which is recorded in Madison County, Iowa, Deed Record No. 15 on page 87 thereof) conveyed said land to Charles A.Gaskill; and the Enos Berger one of the defendents in a case commenced in the Madison County, Iowa, District Court on the 26th day of December, 1860, wherein William Wallace was plaintiff and Charles A, Gaskill and Enos Berger, defenderts; and the Enos Berger, who is one of the defendents in a case commenced on August 24th, 1865, in the Madison County, Towa, District Court, wherein William. Vallace was plaintiff and Enos Berger, Fred Bott and C.A. Gaskill were defendents, is one and the same person in each and all of said conveyances and causes of action/I further depose and say that I was well and personally acquainted with Charles A. Gaskill, or C.A. Gaskill as he sometimes signed his name, and that I know of my own knowledge that C.A. Gaskill was an unmarried man on the 18th day of November, 1870, when he, by warranty deed (which is recorded in Madison County, Iowa, Deed Record No.4, on page 233 thereof) conveyed the land hereinbefore described to one A.D. Taylor; also that the said C.A.Gaskill was an unmarried man on the 16th day of January, 1874, when he, by warranty deed, (which is recorded in Madison County, Iowa, Deed Record No. 9 on page 121 thereof) conveyed 12 acres off of the South side of the above described 40 acre tract of land to Jane Ann Whedon.

I further depose and say that I know of my own knowledge that wherever the names C.A.Gaskill and Charles A. Gaskill appear in the chain of title to the 40 acre tract of land herein before described that said names refer to one and the same person.

I further depose and say that I was well and personally acquainted with A.D. Taylor, who, on Jamuary 1st, 1872, by warranty deed, (which is recorded in Madison County, Iowa, Deed Record No. 6, on page 263) conveyed the above described 40 acre tract of land to Elizabeth R. Taylor, his wife, and that he is one and the same person who joined with his wife as Albert D. Taylor in a warranty deed conveying said land to J.S. McCaugha, which deed is recorded in Madison County, Iowa, Doed Record No. 13, on page 448 thereof.
All of which is true as I am informed and verily believe.
