I,J.W.Lenocker being first duly sworn on oath depose and say,that Christian Lenocker,grantee in a certain warranty deed dated March 11-1873,conveying the West half (W.1/2) of the Northwest quarter (NW.1/4) of section Thirty four (34),Township Seventy-seven (77) North,Range Twenty Nine (29) West of the fifth P.M.Iowa and recorded in book 8 at page 222 of Madison County,Iowa records was my father and I personally know that Christian Lenocker,grantor in a certain warranty deed,dated February 18-1884,and conveying the West half (W.1/2) of the Northwest quarter (NW.1/4) of Section Thirty four (34),Township Seventy-seven (77) North,Range Twenty Nine (29) west of the fifth P.M.Iowa and recorded in book 23 at page 515 of Madison County,Iowa records is the same identical person as Christian Lenocker, my father,and that the spelling of said name as Charistain Lenocker is an error and that his correct name was Christian Lenocker.

I further depose and say that I was well and personally acquainted with David H.Lenocker my brother and grantee in a certain warranty deed,dated March 26-1875,conveying the Southwest quarter (SW.1/4) of Section Twenty Seven (27),Township Seventy Seven (77) North,Range Twentt-nine (29) west of the fifth P.M.Iowa,except one acre deeded for school purposes,and recorded in book 10 at page 595 of Madison County,Iowa records and I know of my own personal knowledge that D.H.Lenocker upon whose estate administration was had in Madison County Iowa as shown by probate record "P" at page 337 of Madison County,Iowa records was one and the same identical person as David H.Lenocker,grantee above mentioned and that he never married during his life time and was a single person at the time of his death.

I further depose and say that I am the identical J.W.Lenocker,who acted as executor of the estate of said David H.Lenocker,deceased and that I am credibly informed that in the list of heirs of said David H.or D.H.Lenocker,deceased there appears the names Kate Firkin; Rosa Fetz;Lizzie Loeper;Carrie Lechner;Sophia L.Armstrong;Lou Simonds;Mary Koehler et al and that in the will of said D.H.Lenocker as beneficiaries thereof appears the following, Sophia Armstrong;Kate Lenocker;Rose Ann Lenocker;Lizzie Lenocker; Ary Lenocker;Lou Lenocker; Caroline Lenocker et al as shown by probate record "P" at page 337 of Madison County,Iowa records and further in the probate proceedings had upon said estate that an original notice was directed to Rosan Fites;Carrie Lechner;Kate Firkins et al and that service thereof was accepted by Rosan Fetz and Carrie Lechner,et al.;that I know of my own personal knowledge that wherever the name Kate Firkin;Kate Lenocker or Kate Firkins appears in connection with the probate proceedings of the estate of D.H.Lenocker,deceased,it in each and every instance refers to and is one and the same identical person,Kate Firkins and that her maiden name was Kate Lenocker;that wherever the name Rosa Fetz;Rosa Fites;Rose Ann Lenocker;Rosan Fetz appears in connection with the probate proceedings of the estate of said D.H.Lenocker,deceased,it in each and every instance refers to and is one and the same identical person, Rosan Fetz and that her maiden name was Rosan Lenocker;that wherever the name Lizzie Loeper or Lizzie Lenocker appears in connection with the probate proceedings of the estate of D.H.Lenocker,deceased it in each and every instance refers to and is one and the same identical person,Lizzie Loeper and her maiden name was Lizzie Lenocker,that wherever the name Carrie Lechner;Caroline Lenocker;Carrie Lechner;appears in connection with the probate proceedings of the estate of D.H.Lenocker,deceased,it in each and every instance refers to and is one and the same identical person,Caroline Lechner and that her maiden name was Caroline Lenocker;that wherever the name Sophia L.Armstrong or Sophia Souhia Armstrong appears in connection with the probate proceedings of the estate of D.H.Lenocker,deceased refers to and is one and the same identical person,Sophia L.Armstrong;that wherever the name Lou Simonds or Lou Lenocker appears in connection with the probate proceedings on the estate of D.H.Lenocker,deceased,it in each and every instance refers to and is one and the same identical person,Lou Simonds and her maiden name was Lou Lenocker,that wherever the name Mary Koehler or Mary Lenocker appears in connection with the probate proceedings had upon the estate of D.H.Lenocker,deceased,in each and every instance refers to and is one and the same identical person,Mary Koehler and that her maiden name was Mary Lenocker.All of which is true as I verily believe.
