I, Jesse Scott first being duly sworn on oath depose and say, that I was well and personally acquainted with Jesse Barnett, my grandfather, and patentee in patent from the United States to the West One-half (W.  $\frac{1}{2}$ ) of the Northwest Quarter (NW.  $\frac{1}{4}$ ) of Section Thirty Four (34) Township Seventy Seven (77) North, Range Twenty Nine (29) west of the fifth P.M. Iowa as shown by U.S. Record 31 page 48; and to the Southwest Quarter (SW.  $\frac{1}{4}$ ) of Section Twenty Seven (27), Township Seventy Seven (77) North, Range Twenty Nine (29) West of the fifth P.M. Iowa, and that I was well and personally acquainted with Jesse Barnett, and Elizabeth Barnett, grantors, in a certain warranty deed, dated March 27-1856 and recorded in book F. at page 95, and with Jesse Barnett, grantee in a certain warranty deed, dated August 4-1859 and recorded in book U at page 533, and Jesse Barnett and Elizabeth Barnett, grantors, in a certain warranty deed, dated March 31-1862 and recorded in book M. at page 342, in the granting clause of which last described deed I am informed the name of Jesse Barnett appears as Joseph Barnett, and if the name Jesse Barnett so appears in said deed it is an error and refers to said Jesse Barnett, grantor in said deed, all being in Madison County, Iowa records and conveying the West One-half (W.  $\frac{1}{2}$ ) of the Northwest Quarter (NW.  $\frac{1}{4}$ ) of Section Thirty Four (34) Township Seventy Seven (77) North, Range Twenty Nine (29) west of the fifth P.M. Iowa. Also with Jesse Barnett and Elizabeth Barnett, grantors, in a certain conveyance dated March 27-1856, conveying the Southwest Quarter (SW.  $\frac{1}{4}$ ) of Section Twenty Seven (27), Township Seventy Seven (77) North, Range Twenty Nine (29) West of the fifth P.M. Iowa and recorded in book F at page 94 of Madison County, Iowa records.

That the said Jesse Barnett and the said Jesse Barnett in each and every instance above mentioned referred to and was one and the same identical person and that the said Jesse Barnett and Elizabeth Barnett were husband and wife at the date of the execution of each and every instrument above described in which they appear as grantors.
