I, Joel Childres a resident of Winterset, Iowa being first duly sworn, upon my oath depose and say, that Benjamin Childres was my Father, and that the Benjamin Childers who is the grantee in deed dated Dec, 16, 1854 Recorded in Deed Rec "F" Page 504, is the same person as the Benjamin Childress who is grantor in deed made Nov, 5th, 1862, and Recorded in Deed Record "M" Page 358, and that the said Benjamin Childress was a single and unmarried man on Nov, 5th, 1862, and that the proper way to spell his name is Benjamin Childres and that wherever his name appears on the records of Madison County any other way it is a mistake, and that they are all one and the same person.

That Benjamin Childres the grantor in Deed made Aug, 18, 1877 is the same person as Benjamin Childress above mentioned.

That John M. Childres the grantee in deed made Aug, 18, 1877, and recorded in Deed Record 13 page 576 is the same person as John M. Childress the grantor in a deed made Feb, 27th 1866 and recorded in Deed Record "Q" page 493. That Benjamin Childres the grantor in Deed made Jan, 24th, 1866 and recorded in Deed Record "Q" page 391, was a single and unmarried man on Jan, 24th 1866.

That wherever the name on John M. Childres is spelled on the records of Madison County any other way either more or less letters it is all one and the same person and a mistake in recording.

That John M. Childres the grantee in deed made Mar, 1, 1871 and Recorded in Record "4" page 481 is the same person as John M. Childress the grantor in a deed made May, 26th, 1871 and recorded in Record "g" page 435. That John M. Childress the grantor in deed made May 26, 1871 is the same person as John M. Childres the grantee in deed made Mar, 1, 1871 and recorded in Record 4 page 481 and that John M. Childress and Lucinda Childress the grantors in deed made Mar, 26, 1871 and recorded in Deed Record "8, page 435 was husband and wife on May, 26th 1871, and that John M. Childers and Lucinda Childers the grantors in Deed made July 26th, 1873 and recorded in Deed Record 8 page 418 were husband and wife on said date and that they are the same persons as where their names are spelled John M. Childress, and Lucinda Childress, or Childres, and that the proper way of spelling the name Childres is Childres and that where it is any other way it is a mistake.

I am in no way interested in making this affidavit, other than to correct mistakes.
