Blair who was the grantee in a certain deed dated June 28, 1863, executed by Eli Miller and wife, entered of record on page 555 of record N of the records of Madison County, Iowa, and that to my personal knowledge the said Alexander W. Blair is the same and identical person as A.W. Blair who was the grantor in a certain deed dated December 27, 1869, which is entered of record on page 518 of deed record 6 of the records of Madison County, Iowa, conveyed to William E. Blair ten acres in a square form in the North East Quarter ($\frac{1}{4}$) of the North West Quarter ($\frac{1}{4}$) of the North West Quarter ($\frac{1}{4}$) of Section Three (3) Township Seventy-five (75) North of Range Twenty-six (26) and a'fiant further states that the said William E. Blair the grantee in said deed is the same and identical person as W.E. Blair who conveyed the said real estate by warranty deed, dated September 28th, 1876 to John Garmon, which is entered of record on page 455 of deed record Twelve (12) of the records of Madison County, Iowa. And I further depose and say t t that the said Alexander W. Blair is the same and identical person as A.W. Blair who, with his wife joining, executed a deed of date December 27, 1869 conveying five (5) acres in the South East corner of the South West Quarter ($\frac{1}{4}$) of the South West Quarter ($\frac{1}{4}$) of Thirty-four (34) Township Seventy-six (76) North of Range Twenty-six (26) Being forty rods from East to West and Twenty (20) rods from North to South, to Henry Fudge. I further state that A.W. Blair who was the grantee in a certain deed of date December 27, 1869 conveying to Wm.J. Potter, the North Half ($\frac{1}{2}$) of the North East Quarter ($\frac{1}{4}$) of the South West Quarter ($\frac{1}{4}$) of the South West Quarter ($\frac{1}{4}$)

of said Section Township and Range which is entered of record on page 110 of record 4 of the records of Madison County, Iowa, is the same person as Alexander W. Blair who acquired title to said real estate from one William M. Turk which is entered of record on page 365 of deed record One (1) of the records of Madison County, Iowa.
