I, Sarah Edgington, being duly sworn, depose and on my oath say, that I am the person named in the Registry of Heirs in estate of Ramson M. Porter, deceased, late of Madison County, Iowa, as Sarah J. Edgington and the same person as Sarah Edgington, who with my husband J.V. Edgington, conveyed all of my interest in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of sec. 9, and the NW $\frac{1}{4}$ NW $\frac{1}{4}$ and north 15 acres of the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Sec. 10 in Township 74 north of range 2 $\frac{1}{2}$ west of 5th P.M. Iowa, on October 29 1-94, and recorded in the Recorders Office of Madison County, Iowa, in Deed Record 41 on page 415, also the same person as Sarah Edgington, named as grantee in a deed of conveyance for the same land, and executed by V.L. Callison and wife, on January 13th, 1902, and recorded in Deed Record 43 on page 338 in said County, also the same person as Sarah Edgington, who was plaintiff in an action to quiet title to the same land and filed in the District Court of Madison County, Iowa, on March 13th, 1902, and that wherever the names Sarah J. Edgington and Sarah Edgington appear in connection with the title of said land they refer to one and the same person. I further depose and say that I was well and personally acquainted with William R. Porter, who with his wife Eliza J. Porter conveyed an undivided one fourth of the above described land to W.O. Lucas, on March, 31, 1894, the said William R. Porter being my brother, and the said William R. Porter who made said conveyance is the same person who is named in the Registry of Heirs above referred to as William E. Porter, the name William E. Porter being an error. I further depose and say that Samuel Porter, who with his wife Josiophene conveyed an undivided one fourth of the same described land to V.L. Callison on October, 4, 1894, is the same and identical person as Samuel M. Porter named in the Registry of Heirs above referred to, the said Samuel M. Porter being my brother. I further depose and say that I am well and personally acquainted with Preston C. Boling and wife, and that the Preston C. Boling and wife named as defendants in the action to quiet the title to the land as above referred to is the same and identical persons as Preston Boling and Mrs. Preston Boling who was personally served with Original Notice in said Action in Union County Iowa, on September, 3, 1902, and James Boling who was served with said notice on the same day and in the same county is the same and identical person as James W. Boling named in said action as one of the defendants. Witness my hand this 5th, day of February, 1907. Sarah Edgington.
